## **FEC INDOOR YARD SALE GUIDELINES**

- 1. The yard sale will be held Saturday, June 15<sup>th</sup>, 2019 from 8:00 AM to 2:00 PM.
- 2. Load-in/ Set-up for booth participants will be Friday, June 14<sup>th</sup>, 2019 10:00 AM to 5:00 PM No Earlier Please and Saturday, June 15th 7:00 AM to 8:00 AM
- 3. Due to the Fire Code, vendors will be limited to the space in the designated booth only.
- 4. Anyone who occupies the South wall booths must be willing to give FEC staff access to storage closets.
- 5. Space area must be left reasonably clean after sale. Please take all unsold items, boxes and containers with you.
- 6. Space participants have parking provided at upper parking lot. Please leave front parking lot for yard sale customers.
- 7. Any dirty, oily, etc., items must be placed on protective plastic inside your booth.
- 8. Any gas motors shall have no more than ¼ gallon of fuel. Engines must be tested outside.
- 9. Booth vendors will be given 2 entry passes on load-in day. Any additional passes must be arranged through the FEC office.
- 10. Vendors are required to remain open until 2:00 PM on the day of the Yard Sale.
- 11. The FEC reserves the right to move booth locations in the event the number of booths does not the fill the space.
- 12. No refunds will be issued.

Indoor Yard Sale Admittance Fee is \$1.00 at the door. FEC will be responsible for advertising of the sale.
